- *Fewster v. Hoag Hospital*: Achieved extraordinary TRO requiring incapacitated patient to receive life-preserving medical care.
- *Balboa Capitol Corporation v. Parisa Safaei, D.M.D. and Red Rocks Dental*: Entered matter after two years of litigation and obtained in trial court rare reversal of judgment.
- *Ross et al. v. Joseph et al.*: Plaintiffs' counsel in consolidated contract, derivative shareholder, fiduciary duty, and tort matter. Two times a mistrial was declared due to judge recusals in the middle of trial. On eve of the third trial the matter settled.
